CATEGORIES

Boys & Girls u19, u17, u15, u13 – maximum 64 players in each category. The German Junior Open is open to all players under the age of 13, 15, 17, 19 on the 4th of July 2022, as appropriate. Players may only enter one category. The ESF has excluded juniors from Russia or Belarus to enter the event.

SEEDING

Seeding will be done according to the ESF Guidelines. These can be found on the ESF website.

MATCHES & SCORING

All matches will be played as best of five games, under the rules of the WSF. PAR scoring to 11 will be used at all tournaments on the ESF Junior Circuit (to 2 clear points). All game scores will be reported in full. There are at least three matches guaranteed for each player.

REFEREEING

All players will be expected to mark and referee matches.

PRIZES

There will be prize money in the U19 categories and trophies in all other categories.

EUROPEAN SQUASH ID (ESID)

All players, coaches, managers and other officials must be registered with ESF. This must be approved and validated by the relevant MNF. The MNF is responsible for ensuring that all players, coaches, managers and other officials are registered with ESF prior to entry, and their entry is fully supported.

COACHES

All team or individual player coaches designated by their nation as part of their event onsite management team (solely, or in attendance with an appointed team manager) at any Championship held under the auspices of ESF must be ESF Registered i.e. have a ESF European Squash ID as their licence to attend in a formal representative role. This is required at the time of them being registered to attend by their national federation.

DRAWS/SEEDINGS

The seeding and timings for the first match will be circulated to all players or their national/regional associations by e-mail, at least 5 days before the start of the event. Times of first matches will be indicated for their players. The seeding will be carried out using the ESF Junior Rankings valid at the closing date and in accordance with the ESF Junior Circuit Guidelines.

















CORONA REGULATIONS

- All players, coaches, parents etc. who want to enter the CENTER, enter the HOTEL or participate in the tournament MUST be vaccinated. Juniors YOUNGER than 16 years of age are exempted from this rule.
- The vaccination needs to be approved by the German law. At the moment, the Russian and Chinese vaccine for example are NOT approved.
- All players and coaches must provide proof of a negative PCR-test or Rapid Antigen Test not older than 48 hours before entering Germany. This proof must be sent to the organizer.
- A rapid test possibly will be done upon entering the squashcenter on the first day.
- Check <u>www.einreiseanmeldung.de</u> to check for the travel restrictions of your country. PLEASE CHECK REGURARLY FOR CHANGES!!

Contingencies:

- In case the German authorities change the local laws on a short notice and the event cannot take place, we will reimburse the full package amount minus 10% cancellation fee.
- In case of travel restrictions from a specific country we will reimburse the full package amount minus 10% cancellation fee.
- In case of a player, coach or parent tests positive NO reimbursement will be made.

TRANSPORT

If you have booked a package (A-H), we will pick you up from two pick-up spots: at the Hamburg Airport (HAM) or the Hamburg Dammtor train station.

On match days a shuttle service will be provided between hotel and club.

No transport will be available if you book package K.

EYE GUARDS

All competitors at ESF approved Junior tournaments must wear approved protective eye guards, manufactured to an appropriate national safety standard, properly over the eyes at all times during competition play. It is the responsibility of the player to ensure that the quality of the product is satisfactory for the purpose. Players will not be allowed to compete without this protection. Only eye wear approved by the WSF are allowed. See www.worldsquash.org.

INSURANCE

Players enter and play in the tournament at their own risk. Neither the organisers nor the ESF accept any responsibility for injury arising from participating in the event. Players must arrange their own insurance. All players have to wear approved protective eye guards on court.

ESF REGULATIONS & PENALTIES

As specified by the European Squash Federation; to compete in all ESF registered events, all players, coaches, managers and other officials must be registered with ESF. This must be approved and validated by the relevant MNF. The MNF is responsible for ensuring that all players, coaches, managers and other officials are registered with ESF prior to entry, and their entry is fully supported. Players can register with ESF through the ESF tournament software website:

The following penalties will apply, in accordance with the ESF Junior Guidelines, Section E.4.a, E.4.b & E.4.c:

E.4.a) If a player makes a late withdrawal from a tournament (2 days or less before the start date), a doctor's certificate confirming injury/illness must be provided to avoid penalties. The medical certificate (with a translation in English) must clearly state the player's name, date of birth and the nature of the illness/injury; the certificate must cover the date of the relevant tournament and must be sent to the ESF office within two days after the final day of the tournament (email: esf@europeansquash.com; fax +44 1675 443440). Any player making a late withdrawal not supported by a medical certificate will receive zero points for the tournament which will count as one of their 4 best results for the rolling 12-month period and will be taken into account when dividing the points to obtain the ranking average. This penalty will be applied automatically unless the ESF office receives a doctor's certificate within two days of the final day of the tournament.

If a player commits this offence for a second time within a 12-month period, he/she will be banned from the ESF Junior Circuit for a period of 12 months.

b) If a player has entered a tournament and fails to turn up, he/she will receive zero ranking points for the tournament. These zero points will count as one of the player's 4 best results for the rolling 12-month period and will be taken into account when dividing the points to obtain the ranking average. This penalty will be applied automatically.

If a player commits this offence for a second time within a 12-month period, he/she will be banned from the ESF Junior Circuit for a period of 12 months.

c) If a player fails to play out all scheduled matches for any reason other than illness or injury, he/she will receive zero ranking points for the tournament. Illness or injury must be verified by the tournament director and, if possible, by medical certificate sent to the ESF office within two days of the final day of the tournament. If zero points are awarded, the points will count as one of the player's 4 best results for the rolling 12-month period and will be taken into account when dividing the points to obtain the ranking average. This penalty will be applied automatically.

If a player commits this offence for a second time within a 12-month period, he/she will be banned from the ESF Junior Circuit for a period of 12 months.

WEB AND MEDIA PUBLISHING

The German Junior Open will be publishing draws, results, photos of players as well as live footage from matches, players and the venue. As this is part of the German Junior Open tournament rules, German Squash (DSQV) will deem that players and their parents have accepted these regulations by entering the tournament.

PSA

The German Junior Open 2022 is registered with PSA as a Closed Satelite. The best 32 players (girls and boys) in the u17 and u19 categories can claim points with the PSA.

WSF

The German Junior Open 2022 is registered with WSF for World Ranking status for girls and boys u19.

GUIDELINES

This event complies with the European Squash Federation Junior Circuit Guidelines – a copy of which is available on the European Squash Federation website at www.europeansquash.com. All participating member nations should make sure that all relevant people (including coaches, managers and players) are aware of the Guidelines and their requirements.



















SAFEGUARDING

Safeguarding, health and safety Adults interacting with juniors in the organisation and running of ESF Junior Circuit events are in a position of trust and influence. They should always ensure that junior players are treated fairly, with respect, and given suitable support. Tournaments should be run in a safe, positive and encouraging environment. The host Organising Committee, including Tournament Director and Tournament Referee should be trained in safeguarding children according to the host MNF national standards. The health and safety of all persons (players, officials, spectators, tournament staff) involved in or attending a tournament is of paramount importance. The Organising Committee, via the host MNF is responsible for ensuring an appropriate plan is in place for the tournament.

EVALUATION

A link to an online survey will be sent to all participants after the tournament has taken place. Responses are anonymous and will be collated by the ESF office.
